Is this a free clinic?

Except for the copay, Matthew 25 does not charge for services provided at the clinic.

There are fees for dental appliances. Below are examples.

- Dentures
- Partial
- Flippers
- Nightguards

Prices are subject to change. Please contact us for updated prices.

Who pays for labs, x-rays, and other procedures?

Any tests and procedures completed here at Matthew 25 are done without charge. If you need to be referred elsewhere, then special arrangements are made through this clinic by giving you a referral slip, but you still may be responsible for some of the cost.

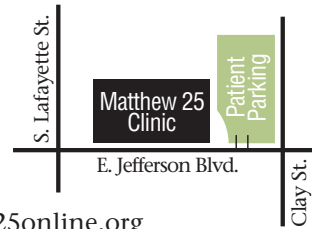
What services are provided at Matthew 25?

Dental services include exams, x-rays, dental and health care instructions, cleanings, fillings, extractions, full dentures, partial dentures.

What services are NOT provided?

Work injuries and motor vehicle accidents are not treated here. We do not do crown and bridge work, implants, orthodontics, or pediatric dentistry.

What can I expect on my first dental visit?

1. Bring identification to show you are an Allen Co. resident, proof of income, and a list of medications that you are currently taking.
2. You will be given a clipboard and a number at the door.
3. The dental personnel will call you to the front desk to discuss Matthew 25 patient qualifications.
4. You will be called back to a dental exam room by an assistant for vital signs and a statement of why you have come.
5. A dentist will then come to examine you.
5. Once the exam is complete you will be asked to wait in the dental area for your next appointment.

Have you read the Matthew 25 Patient Information brochure?

This brochure on dental information is supplemental to the Patient Information brochure — which informs you of general procedures of our clinic. Some information exists in both brochures. The Patient Information brochure gives detail about who qualifies and how to apply to become a patient.

This brochure gives more detail about dental information, services and practices. Note that for dental work, some Medicare recipients and Veterans qualify for care.

How do I get an appointment?

New patients will be seen on a walk-in basis. Patients should be here no later than 8:30 am (except Tuesdays). It is suggested that patient arrive early. Clinics fill quickly.

Patients are considered established patients once they have had a complete oral evaluation. They may call the Dental Scheduler at 426-3250, ext. 258 to make an appointment.

Patients who need immediate treatment will be seen as walk-ins only.

Are There Copays?

Yes. There is a \$10.00 copay for a dental visit (\$5.00 for Walk in)

What if I need to be seen, but I do not have an appointment?

Walk-in patients are seen on Mondays, Wednesdays, Thursdays and Fridays at 8:30. We accept the first eight (8) walk-in patients. You must make arrangements to arrive in the morning.

What if I am going to be late or miss my appointment?

Please call us to reschedule an appointment. If you are going to miss an appointment, please call at least 24 hours in advance. It is our policy that you can only miss three (3) appointments before being considered for dismissal from the clinic, so please pay special attention to your scheduled appointments. [A “miss” is defined as an appointment that you missed and did not call ahead to reschedule.]

Penalty for missing an appointment:

1st missed appointment	90 day
2nd missed appointment	6 mo.
3rd missed appointment	1 yr.

Clinic hours are posted on back and are subject to change. Note that when a fifth Tuesday evening of the month occurs, the clinic will be closed on that evening.

Matthew 25 is a non-smoking property.
